Why do GPs sometimes charge fees?

The National Health Service provides most health care to most people free of charge, but there are exceptions. Sometimes the charge is made because the service is not covered by the NHS, for example, providing copies of health records or producing medical reports for insurance companies.

GPs are not employed by the NHS: they are selfemployed, and have to cover costs for NHS work, but not for non-NHS work.

What is covered by the NHS and what is not?

The Government's contract with the GPs covers medical services to NHS patients, including the provision of ongoing medical treatment. In recent years however more and more organisations have been involving doctors in a whole range of medical work. Sometimes the only reason that GPs are asked is because they are in a position of trust in the community, or because the insurance company or employer wants to ensure that information provided to them is true and accurate.

REQUEST FOR LETTERS FOR THIRD PARTIES

From time to time our patients request information on behalf of third parties.

Whilst we are happy to assist where medical information is required, there will be a charge attached to any such request to provide evidence of something that is not covered by the NHS, and so please think carefully before making such a request eg a letter confirming your registered address. We would ask that you give at least 48 hours notice for any of these requests, and we will endeavour to meet the timescale you require.

Often patients themselves are perfectly able to provide a description of their medical problems and how these affect their needs. This has the advantage that the information is given to the organisation in lay terms which should be easily understood by the non-medical staff.

If there is a requirement for a more detailed medical report, then the requestor should contact the Practice directly with the patients consent.

These requests are not part of the NHS service, and so a charge will be made to the requestor.

The GPs in this practice will therefore <u>not</u> routinely provide third-parties with medical reports or letters, which are requested via our patients.
